¹ Additionally, the General Shareholders' Meeting held on March 14, 2025, approved the payment of a "participation dividend", conditioned to the quorum of the General Shareholders' Meeting reaching 81% of MAPFRE, S.A.'s share capital. Given that the quorum for this meeting was 82.86%, the Board of Directors resolved to pay this dividend on March 19, 2025, to all shareholders entitled to it. The amount of this dividend was 0.001506 euros gross per share, after having applied the amount corresponding to treasury shares to the remaining shares on a proportional basis.
