

## RELEVANT FACT

Pursuant to the requirements of article 82 of the Securities Market Law, notice is hereby given that on 7th July 2011, the Spanish Securities and Exchanges Commission (CNMV) has verified that the requirements have been met for the admission to listing of the SIXTY SEVEN MILLION, THREE HUNDRED AND NINETY EIGHT THOUSAND, NINE HUNDRED AND TWENTY TWO (67,398,922) shares issued in connection to the capital increase approved by the Board of Directors of the Company at the meeting held on 4th May 2011.
